

**REQUEST FOR EXPRESSIONS OF INTEREST
(CONSULTANT SERVICES)**

1. The Government of Nepal has received the FCPF grant from the World Bank toward the cost of Nepal REDD Readiness Preparation Program and intends to apply part of the proceeds for the following consulting service.
2. The objectives of the proposed study are:
To synthesize and consolidate findings of and methodologies adopted in analytical studies carried out during readiness preparation process, to assess progress made by Nepal on REDD+ Readiness through multi-stakeholder workshops at district, regional and national levels, to prepare R-Package report on the basis of criteria and diagnostic questions in the R-Package Assessment Framework.
2. The REDD Forestry and Climate Change Cell now invites eligible consulting firms to indicate their interest in providing consulting services for the development of **R-Package and assessment of REDD+ readiness at national level**. Interested consulting firms must provide information indicating that they are qualified to perform the services [company profile, brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. with supporting documents to substantiate the information provided in the EOI]. Consultants may associate to enhance their qualifications. The association/consortium shall be in the form of joint venture (JV) or intended JV where all the JV members shall be jointly and severally liable for the entire assignment.
3. A consulting firm will be selected in accordance with the procedures set out in the World Bank's [Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers](#) , January 2011 (Consultant Guidelines) adopting selection method of “Quality- And Cost- Based Selection (QCBS)”. The consulting firms will be evaluated and short-listed based on the approved evaluation criteria that are broadly based on the following categories.

A. Eligibility Criteria

- i) Valid registration certificate; ii) Tax clearance or renewal of tax certificate; iii) VAT/PAN registration certificate (For international consultants to be submitted at the time of contract signing); iv) consulting firm must be registered since last THREE years; v) legally binding joint venture agreement in case of applying in joint venture and vi) Fulfilment of the Bank's Conflict of Interest criteria

B. Ranking Criteria for

Ranking criteria are broadly based on the following three categories.

- i) **General Experiences:** Number of Projects Completed Successfully
- ii) **Specific/Similar/Relevant Experiences** (each completed project not less than value of USD 0.03 million):
 - i) Number of completed projects related to development of national strategies and policies;
 - ii) Number of completed projects related to evaluation of national level programs/projects;
 - iii) Number of completed projects related to evaluation of forest sector policies/strategies and
 - iv) Number of completed projects related to evaluation of REDD related programs/projects
- iii) **Organizational setup of the consulting firm:** office, equipment, office organization and management and annual turnover taken for the best two years from last three years.

- 4 Expression of Interest must be clearly marked "Expression of Interest (EOI) for consulting services for **FCPF/REDD/S/QCBS-21: Development of R-Package and Assessment of REDD+ Readiness at National Level.**
- 5 The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Consultant Guidelines, setting forth the World Bank's policy on conflict of interest.
